## INTENT TO RELINQUISH MOORING SITE PERMIT AND PERMISSION TO SELL MOORING GEAR

- I understand that mooring gear is personal property which I am ultimately responsible for removing if not transferred by me to another permit holder approved by the Harbormaster.

Note: The Harbormaster and Staff cannot be "brokers" of mooring gear. Gear owners must negotiate for the sale of their mooring gear directly with the new site permittee.
