- ✓ All boats, 12 feet in length and over, whether on a mooring, private or commercial dock, must be registered with the Harbormaster each year. Failure to register in a timely manner **will subject vessel owner to violation fines as well as hauling, transportation, and storage costs.** Calculate your waterways fee from the fee schedule below and return Forms, with a check in the proper amount, **payable to: Town of Dartmouth**, to the address below.
- ✓ All Dartmouth Mooring areas, including the Harbor channels, are “No Wake Zones” under State and local laws. Speeding and safety regulations are strictly enforced for the safety of all boaters.
- ✓ **Any Change in “Vessel of Record” assigned to a mooring permit requires prior written Harbormaster approval.**
- ✓ Owners; please keep a record of your **vessel’s important serial numbers**, especially outboards, outdrives, and electronics. Dartmouth provides “Operation ID” services for engraving your valuables, contact us for assistance.
- ✓ **Please be advised:** All of Buzzards Bay, including all Dartmouth waters, is designated a “**no-discharge zone**”. Don’t Dump – We Pump! For **free** pump-out services, call us: on Channel 9 VHF; at (508) 999-0759; e-mail [harbormaster@dartmouthharbormaster.com](mailto:harbormaster@dartmouthharbormaster.com); or **request to be placed on our weekly pump-out list.**
- ✓ **Please Note:** Payment of **vessel excise tax** to the Town of Dartmouth is required for accommodation of your vessel on any mooring or dock in Dartmouth waters.
- ✓ Your Waterways **USE PERMIT DECAL** will be mailed to you upon our receipt of your “Form A” and correct fee. The **USE PERMIT DECAL must be visibly displayed** on the upper port corner of your transom.
- ✓ **YOU ARE RESPONSIBLE FOR COMPLYING WITH ALL DARTMOUTH WATERWAYS AND MOORING REGULATIONS.** (see [www.dartmouthharbormaster.com](http://www.dartmouthharbormaster.com) for current regulations and information )
